

**Associate of Arts Admissions Cooperation Agreement between  
Seattle College District  
And  
St. Cloud State University**

To create a clear and easy pathway for students of the Seattle College District (SCD), consisting of North Seattle College, South Seattle College and Seattle Central College, to transfer to and complete their baccalaureate degree at St. Cloud State University, this transfer agreement outlines transfer requirements, provisions, and related advertising considerations. This agreement does not guarantee admission to the university or to the specific program/major.

1. Upon completion of the Associate of Arts degree (A.A.) degree at the Seattle Colleges, students will be accepted by St. Cloud State University at junior status with 90 quarter (60 semester credits) transfer credits. St. Cloud State University is on a semester system. Transferring students must have a minimum cumulative grade point average (GPA) of 2.0 or C. Courses numbered lower than 100-level are not included in this transfer agreement.

Transfer of more than 90 quarter (60 semester) credits will be considered on a course by course basis up to a total of 120 (80 semester credits) lower division (100/200 level) quarter credits. Courses with a grade lower than C- or 1.67 will not be considered for transfer.

2. International students who complete ENG 101 and ENG 102 with a grade of 2.0 or higher will have met the English proficiency requirements of SCSU, and will not need to submit separate proof of English proficiency at the time of application.
3. SCD and St. Cloud State University shall co-develop written materials outlining for SCD students programs, policies and procedures relevant to this agreement, to include Pathways to complete program requirements including St. Cloud State University general education requirements. This agreement will be publicized in newsletters, course schedules and other promotional materials.

This Agreement is effective on 09/01/2015 and shall remain in effect until the end date of 09/01/2020 or for five years, whichever occurs first, unless terminated or amended by either

party with 90 days prior written notice. This Agreement will be reviewed by both parties beginning 03/01/2020 (within six months of the end date).

SCD and St. Cloud State University officially authorize this agreement on September 1, 2015, with the agreement becoming effective immediately.


